LAYOUT NOTES:

- (1) This file is provided as an alternative to the current “Prospective_MIP.txt” file currently posted on the Bulk Download page. The purpose of this new file is to provide the information in the format consistent with the existing Consolidated Disclosure File “D” Record. This is not a new file of data but a potential ease of use for users that would prefer to process a fixed length, fixed field record format, which is the same as the existing “D” record. It provides the same “prospective” Multiple Issuer Pool (MIP) data for 15-year, 30-year, and Adjustable Rate Mortgage (ARM) pools as the existing “Prospective_MIP.txt file. The file has all of the prospective pools for future issuances. The data is prospective and may not result in an issued pool (the data does not represent the issuance of a Ginnie Mae security).
- (2) All records/fields are fixed length. The file contains only “D” records without a file header or trailer.

1. CUSIP Number: A nine character unique identifier for the MBS security for the pool.
2. Pool ID: The six character identifier for the pool.
3. Pool Indicator: The type of issue. All records in the file will be type M.
4. Pool Type: The two character pool type for the pool.
5. Record Type: "D" for the Prospective MIP Disclosure Record.
6. Security Interest Rate: The interest rate of the security.
7. Pool Issue Date: Issue Date of the pool (CCYYMMDD).
8. Nominal Pool Maturity Date: The final maturity date of the pool (CCYYMMDD).
9. Reserved (Filler): This field is populated by 999s.
10. Issuer Number: This field is populated as "9999".
11. Issuer Name: This field is populated as "Multiple Issuers".
12. Security Margin (ARM Pools only): The amount added to the ARM Index. This is populated as "0000" for non-ARM pools.
- 13-100. Reserved (Filler): These field are populated by 999s.
101. Filler: The field is populated by blanks.
102. As of Date (CCYYMM): The effective issue month for the data in the record.
